FINAL JUDGMENT

This action and all triable issues presented by it were tried before the Court with a jury commencing on February 6, 2017. The verdict of the jury, returned on February 21, 2017, is hereby made the judgment of the Court.

1. In its verdict, the jury awarded damages in the amount of \$27,822,777.12 on the claim of Plaintiff Advocacy Trust of Tennessee, LLC, as Conservator for Shannon Maria Trabue, as compensation for Shannon Maria Trabue's personal injuries proximately caused by the negligence of Atlanta Women's Specialists, LLC physician employees Stanley R. Angus, M. D. and Rebecca V. Simonsen, M.D. IT IS THEREFORE ORDERED AND ADJUDGED that the Plaintiff Advocacy Trust of Tennessee, LLC, as Conservator for Shannon Maria Trabue, recover of the Defendants Atlanta Women's Specialists, LLC and Stanley R. Angus, M.D., jointly and severally, the sum of \$27,822,777.12, together with interest thereon at the lawful rate of 6.75% per annum¹ from and after February 21, 2017, together with all costs of this action.

2. In its verdict, the jury awarded damages in the amount of \$18,000,000.00 on the claim of Plaintiff Keith Trabue, individually, as compensation for his loss of consortium arising out of Shannon Maria Trabue's personal injuries proximately caused by the negligence of Atlanta Women's Specialists, LLC physician employees Stanley R. Angus, M. D. and Rebecca V. Simonsen, M.D. IT IS THEREFORE ORDERED AND ADJUDGED that the Plaintiff Keith Trabue, individually, recover of the Defendants Atlanta Women's Specialists, LLC and Stanley R. Angus, M.D., jointly and severally, the sum of \$18,000,000.00, together with interest thereon at the lawful rate of 6.75% per annum² from and after February 21, 2017, together with all costs of this action.
