Defendants hereby offer the sum of One Million Two Hundred Thirty-Three Thousand One Hundred Fourteen Dollars and Forty-Eight Cents (\$1,233,114.48) for a full, final and binding settlement of the entirety of Plaintiff's claims in this litigation against Defendants.

Plaintiff has twenty (20) days from the date of the filing of this Offer of Judgment to accept this offer. If written notice of acceptance is not given to the undersigned within the twenty (20) days specified, the Offer is withdrawn and cannot be introduced into evidence. In addition, if Plaintiff obtains a judgment less than or equal to of One Million Two Hundred Thirty-Three Thousand One Hundred Fourteen Dollars and Forty-Eight Cents (\$1,233,114.48) against Defendants, said judgment shall be reduced by eight percent (8%) interest computed on the amount of the judgment from the date of this Offer to the date of entry of said judgment. Additionally, Pursuant to S.C. Code Ann. § 15-35-400(b) and SCRP 68, if Plaintiff does not accept

this Offer of Judgment and Plaintiff fails to obtain a verdict or determination at least as favorable as this offer against Defendants, Defendants shall seek to recover from the Plaintiff any administrative, filing, or other costs from the date of this offer until judgment.

Defendants reserve the right to withdraw this Offer of Judgment prior to its acceptance or prior to the date on which it would be considered rejected by giving notice to Plaintiff in accordance with the service rules for motions and other pleadings outlined in the South Carolina Rules of Civil Procedure. However, by making this Offer of Judgment, Defendants do not waive its right to seek any greater remedies that may be available to it than those set forth in S.C. Code Ann. § 15-35-400 and Rule 68, SCRP.

On or before the twentieth (20th) day from the date of the filing of this Offer of Judgment, the Plaintiff or his attorney may file with the Clerk of Court a written acceptance of this Offer of Judgment and serve it upon Defendants in accordance with the South Carolina Rules of Civil Procedure.
